Advisory committee report: ocna 41 is doing very well they are right on schedule no movement or updating the guidelines they're still waiting on a response to propose revisions.

Open positions at a regional level: are as following vice secretary, vice treasurer, outreach chair, vice Webmaster, ocna AC3.

Spring 12 traditions retreat chair report :12 traditions retreat has met twice so far and all positions are filled their next retreat dates will be May 9th through May 11th and their theme is going to be create freedom and responsibility go hand in hand they will be holding a fundraiser December 14th at the hope spot in Xenia OH from 1:00 PM to 5:00 PM the theme will be gifts of recovery they will include an open mic to share on that topic and they will have food they will have Flyers to region very soon they hope to see us there.

H& I chair report: since her last meeting she followed up on open threads brought up at the meeting she reached out to Coasna RCM, the regional PR chair the RCM who asked about the facility and Westerville requesting a meeting, as well she made a courtesy call to the newest areas RCM of southern Ohio Valley area to offer to attend the next area meeting with her their H&I trusted servants or interested members and sharing their experience strength and hope she is available to any RCM's by phone or e-mail and would like to talk, problem solve ideas, offer experience, strength, and hope or just pass information to your H& I chair. her e-mail is handi@na.org, and her phone number is 937-266-8383. She requested 150 dollars to buy literature. Her plan between now and the next regional meeting is to purchase literature to make welcome packets, these will be made available to H&I chairs and facilities along with the generic letter that can be tailored to specific needs, the idea is that this would be a one-time donation to each area if needed they can feel free to decline the packets can be recreated by local H&I committees there's a great need for the message to be carried to addicts but the theme shared by RCM's is that there are not enough addicts willing or able to carry the message, this is something that the region can offer as an educational tool for facilities in places where there are not enough addicts to carry in a panel. Also, Emily has a member

willing to step up and serve as regional H& I chair next year, and she has been working with him and training him.

Public relations chair report she wants to establish that it is recognized without argument that the individual NA member is the most valuable PR resource of our fellowship has. In the past three months since she met with region the Na.org website went down for reconstruction it was difficult if not impossible to access in a literature online or find resources that any members have contributed to NA's beginnings, it became apparent when she attended we all are PR event organized by the PR task force while PR chair of the Mvascna area that many areas have developed resources for local use only, and no real way to actually share it it with other areas in their region, except from word of mouth or knowing someone who actually knows. Out of that need she created a Google Drive that contains all manner of downloadable resources developed by individual and members everywhere in their course of NA service. There are handbooks, IP's, PSA videos, artwork for websites and cool logos tips for everything, with experience on how other areas do their stuff, and a link to a discussion board specific to the website. These resources are available at Via a Google website at www.eachteachna.org.

One of the main things that I took from region in this last quarter is that a lot of areas still struggle with having recovering addicts willing to do service or willing to step up, it seems to be the theme. A lot of areas still struggle with meeting attendance and also struggle with financials.
