Hello Family, my name is Angel, and I am a grateful recovering addict. Thank you for allowing me to be of service. It is with great pleasure that I provide the quarterly report listed below.

The geographical area served by the MEASCNA Area is Licking, Fairfield, Muskingum, Guernsey, Coshocton, Perry, and Knox counties. Our area presently has 24 groups, 43 weekly meetings, and 3 H&I panels. At our last Area Service Committee meeting, 13 groups service representatives were present.

The area service meeting is held on the first Monday of each month at 6:30pm at the Faith United Methodist Church located at 261 East Main Street Newark, OH.

Currently, all MEASCNA area service positions are filled.

In the past three months, 1 new group has been started in our Area: Unnamed Women's group at 62 E Stevens Street Newark, OH Mon-Fri 12pm-1pm. In the past three months, 1 group has folded.

The MEASCNA Area has recently implemented use of our website to include area service meeting minutes, treasurer reports, literature/merchandise reports, committee reports, subcommittee reports, group donations report, MEASCNA policy, and events.

December monthly expenses for the MEASCNA Area at our last ASC meeting were \$1,592.84. Total donations from groups to the Area were \$1,882.00. We are donating a check today in the amount of \$800.00 to the Ohio Region as it was discovered that no donations had been made in the last 2 years. This was discovered during a policies review and the plan moving forward is for the RCM or the RCMA to bring a check to each quarterly regional meeting.

The MEASCNA Area purchases literature from NAWs. Literature is sold to area groups, donated to institutions, and sold at conventions. The balance at the start of December 2022 was \$1,819.33. The balance at the end of December 2022 was \$3,365.23 with sales for the month totaling \$1,545.90.

Upcoming events in our area are a Valentine's Day Event on Feb 11, 2023 and a St. Patrick's Day Event on March 18, 2023. In December there was a Free Holiday Function and a New Year's Eve event. Both were well attended and enjoyed by all.

## RCM report to MEASCNA AREA from the January 2023 ORSCNA Meeting

Hello family, I attended the January 2023 Ohio Region Service Committee of Narcotics meeting held in Marion, Ohio on Jan 14<sup>th</sup> and 15<sup>th</sup>, 2023. Below is a summary of the meeting happenings.

- There are several open positions at the Regional level: Vice Secretary, Public Relations chair, H&I chair, OCNA Advisory Committee member 2 and 3. If anyone is interested, please fill out a nomination form and it can be taken to the next Regional meeting in April.
- Votes on Motions 2022-09, 2022-10, 2022-13 were taken back to the Regional Service Committee. The final vote results were as follows:  
Motion 2022-09 yes=6 no=0 abstained = 2 Spring Retreat prudent reserve now \$2,000  
Motion 2022-10 yes=5 no=2 abstained= 1 Fall Retreat prudent reserve now \$3,800  
Motion 2022-13 yes=4 no=2 abstained= 2 A Regional member may also hold an Area service position (2 hatting)
- The MEASCNA vote to decline hosting the OCNA 40 in December 2025 was reported to ORSCNA
- \*\*\*\* There are 25 motions at the World Service level that need voted on at the group level and votes returned to AREA meeting by March 6<sup>th</sup>. 2023-002 RD member to accept funding from WSC to send a seasoned delegate to the WSC with the current RD and RDa (as neither had been to convention before d/t COVID) Vote yes=8 no=0 Abstain= 0  
2023-003 OCNA 39 to borrow \$4,00 from ORSCNA for the intent of paying towards the hotel reservation. This money will be paid back to ORSCNA after the convention. Vote yes=7 no=0 abstain=1  
Motion 2023-004 To purchase a virtual meeting system not to exceed the amount of \$600. Vote yes=6 no=2 abstain=0
- Treasury Report : balance at start of meeting on Jan 14, 2023 was \$ 17,009.51 and the balance at end of day Sunday Jan 15, 2023 was \$ 16,868.93
